MINUTES OF A REGULAR MEETING OF OF THE BOARD OF DIRECTORS OF THE CASCADE METROPOLITAN DISTRICT NO. 1 HELD FEBRUARY 25, 2014

A regular meeting of the Board of Directors of the Cascade Metropolitan District No. 1 (the "Board") was duly held on Tuesday, the 25th day of February, 2014, at 5:00 p.m., at the Cascade Fire Station, 8015 Severy Road, Cascade, Colorado. The meeting was open to the public.

DISCLOSURE OF POTENTIAL CONFLICTS OF INTEREST

Disclosure of Potential or Existing Conflicts of Interest: The Board discussed the requirements pursuant to Colorado law to disclose any potential or existing conflicts of interest to the Board of Directors and to the Secretary of State. Ms. Tanaka reported that disclosures for those directors with potential conflicts of interest were filed with the Secretary of State's Office and the Board at least 72 hours prior to the meeting, in accordance with Colorado law, and those disclosures were acknowledged by the Board and are attached hereto. Director Anderson noted that a quorum was present and inquired into whether members of the Board had any additional disclosures of potential conflicts of interest with regard to any matters scheduled for discussion at this meeting. No additional disclosures were noted.

ADMINISTRATIVE MATTERS

Agenda: Mr. Gomes reviewed the proposed Agenda for the District's regular Board Meeting.

Following discussion, upon motion duly made by Director Whittemore, seconded by Director Justis and, upon vote, unanimously carried, the Agenda was approved, as amended.

Public Comment: A member of the public asked about Director Anderson's conflicts of interest because he could not find any Conflict of Interest filings for Director Anderson on the Colorado Secretary of State's website. Ms. Tanaka responded that Director Anderson's Conflicts of Interest have been filed with Secretary of State on a timely basis and she will check the website to ensure they are showing up properly. Director Anderson explained his conflicts of interest related to the District. Several members of the public commented on the proposed Monthly Water Provision Fee for the City of Colorado Springs and Colorado Springs Utilities. Many of those commenting on this fee were against its adoption. There were a few questions and comments about the alleged embezzlement of District funds. Directors responded to those questions to the extent that was possible. There was a request to identify the firm that performed the audits during the alleged embezzlement. The name of the firm was not disclosed. There was a question as to whether Special District Management Services, Inc. had insurance coverage that would indemnify the District for criminal acts causing a loss to the District. Mr. Gomes responded that SDMS has professional liability insurance. general liability insurance, and insurance covering criminal acts. Several members of the public asked if the City of Colorado Springs would assume ownership of the District's water system. Director Anderson responded that significant and costly improvements would need to be made to the District's infrastructure to bring it to a level that the City would require before accepting it. He said that the District may be better served by getting the water rights previously owned by the Cascade Public Service Corporation returned to the District and developing a water treatment system to serve its customers. There was a substantial amount of interaction between the Directors and the public related to several public members wanting to be included in the District. This interaction resulted in the Board directing Ms. Tanaka to draft a document summarizing the process of including the District's customers into the District's boundaries. This document is to be reviewed by the Board and will be sent to the property owners in the service area with the April billing.

<u>Minutes</u>: The Board reviewed and considered the minutes from the January 28, 2014 Regular meeting.

Following discussion, upon motion duly made by Director Herr, seconded by Director Justis and, upon vote, unanimously carried, the Minutes were approved as presented.

The Board then reviewed and considered the Minutes of the February 5, 2014 Special meeting.

Following discussion, upon motion duly made by Director Herr, seconded by Director Justis and, upon vote, unanimously carried, the Minutes were approved as presented.

FINANCIAL MATTERS

<u>Claims</u>: The Board considered approval of the payment of payables through the period ending February 25, 2014, totaling \$37,710.28.

Following review and discussion, upon motion duly made by Director Whittemore, seconded by Director Eason and, upon vote, unanimously carried, the Board approved the payment of payables, subject to availability of funds.

<u>Cash Analysis</u>: Mr. Gomes presented the cash analysis to the Board and reviewed the current balances noting that after the claims are paid, there will be \$586.33 remaining in the fund.

2012 Audit: Mr. Gomes reported that the audit is still in process and he has no new update. The Board requested that Mr. Gomes push the completion of the audit with the auditor.

Resolution No. 2014-02-01; Amended and Restated Resolution Concerning the Imposition of Various Fees, Rates, Penalties and Charges for Water Services and Facilities: The Board discussed and considered Resolution No. 2014-02-01; Amended and Restated Resolution Concerning the Imposition of Various Fees, Rates, Penalties and Charges for Water Services and Facilities.

Following discussion, upon motion duly made by Director Whittemore, seconded by Director Justis and, upon vote, unanimously carried, the Board adopted Resolution No. 2014-02-01; Amended and Restated Resolution Concerning the Imposition of Various Fees, Rates, Penalties and Charges for Water Services and Facilities, as amended to state that the Monthly Water Provision Fee for the City of Colorado Springs and Colorado Springs Utilities will terminate when the balance due to the City is paid in full. A copy of the adopted Resolution is attached hereto and incorporated herein by this reference.

Monthly Fee For Past Water Provided by City of Colorado Springs and Colorado Springs Utilities: The Board approved this fee as part of the approval of Resolution No. 2014-02-01.

<u>Monthly Water Service Charges</u>: The Board deferred consideration of these charges to the March meeting.

<u>Imposition of Availability of Service Charges</u>: The Board deferred consideration of these charges to the March meeting.

OPERATIONS MATTERS

<u>Operators Report</u>: Mr. Kilik reported to the Board that there is another broken fire hydrant. The Board directed Mr. Kilik to get an estimate for repair of the hydrant and file an insurance claim.

Mr. Kilik also reported that the City of Colorado Springs is preparing to apply for a 1" water tap from the District for its Visitor Center by Tollgate. Mr. Kilik recommended that Board require the City to install a fill station rather than using unmetered water from the fire hydrant. The Board agreed and noted that the fill station will be a requirement for the issuance of the tap.

Mr. Kilik noted that there is a water loss of approximately 45%-50% again. He believes the area at Rampart Terrace is the cause of this loss and would like to investigate this. However, due to safety concerns, he needs additional people to assist in this effort. Director Whittemore volunteered to help Mr. Kilik in these efforts.

Mr. Kilik reported that the District's water usage and loss from January 2013 to January 2014 is down by approximately two million gallons and there seems to be no explanation for this. He noted that new meters and remotes were purchased but there seems to be no explanation for the reduction.

Stults Residence: The Board reviewed a proposal from Lamb Plumbing & Excavating, Inc. for service line replacement services at the Stults residence. The Board directed Legal Counsel to prepare an agreement for the work and directed Mr. Gomes to research the funds available for the project.

Account 130 Request: Mr. Gomes presented the Board with a request from the property owner of account #130 to reclassify the property from a ¾" commercial to a ¾" residential tap.

Following discussion, upon motion duly made by Director Whittemore, seconded by Director Justis and, upon vote, unanimously carried, the Board denied the request to reclassify. The Board noted that if the property owner can provide evidence of the reclassification then it will reconsider the request in the future.

Account 479 Request: Mr. Gomes presented a request from the property owner of account #479 and noted that there was an unusually high water usage in November that is unaccounted for and cannot be explained. The property owner addressed the Board and noted that all possible areas have been investigated for leaks and nothing has been found. The Board discussed the request. The Board directed staff to waive the late charges imposed since November and directed the water operator to contact the resident's tenant to determine whether he is aware of any water being left on or leaks. The Board deferred action to the March meeting.

LEGAL MATTERS

Resolution No. 2014-02-02; Resolution Relating to and Reaffirming the Creation of its Water Activity Enterprise: The Board reviewed Resolution No. 2014-02-02; Resolution Relating to and Reaffirming the Creation of its Water Activity Enterprise.

Following discussion, upon motion duly made by Director Herr, seconded by Director Whittemore and, upon vote, unanimously carried, the Board adopted Resolution No. 2014-02-02; Resolution Relating to and Reaffirming the Creation of its Water Activity Enterprise. A copy of the adopted Resolution is attached hereto and incorporated herein by this reference.

Resolution No. 2014-02-03: Resolution Amending 2014 Annual Administrative Matters Resolution: The Board reviewed Resolution No. 2014-02-03: Resolution Amending 2014 Annual Administrative Matters Resolution which changes the designated newspaper for legal notices for the District. Following discussion, upon motion duly made by Director Whittemore, seconded by Director Justis and, upon vote, unanimously carried, the Board adopted reviewed Resolution No. 2014-02-03: Resolution Amending 2014 Annual Administrative Matters Resolution. A copy of the adopted Resolution is attached hereto and incorporated herein by this reference.

Independent Contractor Agreement with JDS-Hydro Consultants, Inc. for District Engineering Services: The Board reviewed the Independent Contractor Agreement with JDS-Hydro Consultants, Inc. for District Engineering Services.

Following discussion, upon motion duly made by Director Justis, seconded by Director Eason and, upon vote, unanimously carried, the Board approved the

Independent Contractor Agreement with JDS-Hydro Consultants, Inc. for District Engineering Services.

Rules and Regulations: Mr. Gomes noted that he requested a proposal from Ms. Tanaka and JDS-Hydro for drafting rules and regulations for the District. Mr. Anderson inquired into the issues with the current regulations. Mr. Gomes noted there are many things including the demarcation line for responsibilities of the property owner versus the District need to be revisited. Ms. Tanaka suggested that she review the current rules and regulations to determine whether they are sufficient, whether revisions need to be made or whether new regulations need to be considered. The Board directed Ms. Tanaka to do this and report back.

Status of May 6, 2014 Election: Ms. Tanaka reported that self-nomination and acceptance forms are due to Mr. Gomes, the Designated Election Official, by no later than 5:00 P.M. on Friday, February 28, 2014. Affidavits of Write-In Candidate are due on Monday, March 3, 2014. In the event there are no more candidates than positions up for election, the election may be cancelled on May 4, 2014.

ADJOURNMENT

There being no further business to come before the Board at this time, upon motion duly made, seconded and, upon vote, unanimously carried, the meeting was adjourned.

Resolution No. 2014-02-01

AMENDED AND RESTATED RESOLUTION OF THE BOARD OF DIRECTORS OF CASCADE METROPOLITAN DISTRICT NO. 1

CONCERNING THE IMPOSITION OF VARIOUS FEES, RATES, PENALTIES AND CHARGES FOR WATER SERVICES AND FACILITIES

WHEREAS, pursuant to an Order of the District Court in and for El Paso County, Colorado, the Cascade Metropolitan District No. 1 (the "District") was duly and validly organized and exists as a metropolitan district in accordance with Colorado law; and

WHEREAS, the District owns, operates and maintains various water facilities and improvements (the "Improvements") and provides associated services to its users, residents, taxpayers and property owners; and

WHEREAS, pursuant to § 32-1-1001(1)(j), C.R.S., the District is authorized to fix and impose fees, rates, tolls, charges and penalties for services or facilities provided by the District which, until paid, shall constitute a perpetual lien on and against the property served, the revenues from which fees, rates, tolls and charges may be pledged to the payment of any indebtedness of the District; and

WHEREAS, the District desires to establish the water charges, usage fees and equivalency rates in order to finance the costs associated with the District's general operations and the District's operation and maintenance of the Improvements; and

WHEREAS, pursuant to § 32-1-1006(1)(h), C.R.S., the District is empowered to assess availability of service or facilities charges for the purpose of paying principal of an interest on any outstanding indebtedness or bonds of the District; and

WHEREAS, pursuant to § 32-1-1006(1)(g), C.R.S., the District is empowered to fix and from time to time increase or decrease tap fees; and

WHEREAS, the District desires to impose a tap fee as a one-time contribution required of new customers to be used for capital investment in regional facilities and District operations, as well as a related tapping fee to cover the District's actual costs associated with the new tap and the incorporation of the new service to the District's systems; and

WHEREAS, the water charges, usage fees, equivalency rates, availability of service charges and tap fees are referred to herein as the "Fees" or a "Fee"; and

WHEREAS, the District finds that the Fees set forth herein are reasonably related to the Improvements and services provided by the District and that imposition thereof is necessary to provide the services and facilities serving the property subject to such Fees.

NOW, THEREFORE, be it resolved by the Board of Directors of the District as follows:

- 1. <u>Fees</u>. The District hereby establishes the Fees set forth in **Exhibit A**, attached hereto and incorporated herein by this reference. All prior resolutions adopted by the Board which impose fees, rates, tolls, penalties or charges, are hereby replaced and superseded in their entirety with this Resolution. Any fees, rates, tolls, penalties or charges due under such prior resolutions, to the extent outstanding and unpaid, shall remain in effect until fully paid and shall not be eliminated hereby.
- 2. <u>Late Fees and Penalty Interest</u>. Any Fee that is not paid in full within Fifteen (15) days after the scheduled due date shall be assessed a late fee in the amount of Fifteen Dollars (\$15.00) pursuant to § 29-1-1102(3), C.R.S. Interest will also accrue on any outstanding Fee, exclusive of assessed late fees and interest, at the rate of 12% per annum, pursuant to § 29-1-1102(7), C.R.S, and § 32-1-1006(1)(d), C.R.S.
- 3. <u>Payment</u>. Payment for each Fee shall be made payable to "Cascade Metropolitan District No. 1" and sent to the following address, on or before the due date: Cascade Metropolitan District No. 1, 141 Union Boulevard, Suite 150, Lakewood, Colorado 80228.
- 4. <u>Fees Constitute Lien</u>. The Fees imposed hereunder each shall, until paid, constitute a perpetual lien on and against the property served, and any such lien may be foreclosed in the manner as provided by the laws of the State of Colorado for the foreclosure of mechanic's liens, pursuant to § 32-1-1001(1)(j), C.R.S.
- 5. <u>Collection Procedures</u>. The District shall undertake collection efforts for any amounts outstanding, including late fees, interest and attorneys' fees, in accordance with Federal and Colorado law.
- 6. <u>Certification of Account to County Treasurer</u>. Pursuant to §32-1-1101(1)(e), C.R.S., the Board may elect to certify any delinquent account and late fees satisfying the criteria established therein to the County Treasurer for collection with the District's *ad valorem* property taxes. The certification process may be in addition to or in lieu of any procedures set forth in this Resolution in the Board's sole discretion. The fees for the certification process shall be in accordance with Colorado law and County policy.
- 7. <u>Severability</u>. If any clause or provision of this Resolution is adjudged invalid and/or unenforceable by a court of competent jurisdiction or by operation of any law, such adjudgement shall not affect the validity of this Resolution as a whole, but shall be severed herefrom, leaving the remaining provisions intact and enforceable.
- 8. <u>The Property</u>. This Resolution shall apply to all property served by the District, any property within the District's boundaries and any additional property included into the

District's boundaries after the date of this Resolution. This Resolution shall be recorded on the properties set forth in **Exhibit B**, attached hereto and incorporated herein by this reference.

9. <u>Effective Date</u>. This Resolution shall become effective as of February 25, 2014.



Thereupon there was introduced the following Resolution, copies of which had been distributed previously to each Director, whereupon the Resolution was read as follows:

RESOLUTION

A RESOLUTION ESTABLISHING A WATER ACTIVITY ENTERPRISE UNDER STATE LAW WITHIN CASCADE METROPOLITAN DISTRICT NO. 1; ACKNOWLEDGING THAT SUCH WATER ACTIVITY ENTERPRISE HAS THE AUTHORITY TO ISSUE ITS OWN REVENUE BONDS UNDER STATE LAW; MAKING CERTAIN FINDINGS WITH RESPECT TO SUCH ENTERPRISE; AND PROVIDING OTHER DETAILS IN CONNECTION THEREWITH.

WHEREAS, the Cascade Metropolitan District No. 1, County of El Paso, Colorado ("District") shall be responsible for the provision of all water activities, including the construction of the public water projects and facilities for the District consistent with its service plan; and

WHEREAS, the District desires to establish and reaffirm the establishment of its water activity enterprise (the "Enterprise") under Colorado law; and

WHEREAS, the members of the governing body of the District (the "Board") are willing and intend to act as the governing body of the Enterprise; and

WHEREAS, pursuant to Title 37, Article 45.1, Part 1, Colorado Revised Statutes (the "Act"), the establishment of water activity enterprises within or by entities of state and local government is critical to the health and welfare of the people of the State of Colorado; and

WHEREAS, the Act defines a "water activity enterprise" to include any government water activity business owned by a district, which enterprise receives under ten percent of its annual revenues in grants from all Colorado state and local governments combined and which is authorized to issue its own revenue bonds pursuant to this article or any other applicable law; and

WHEREAS, "district" is defined in the Act to include special districts organized and operating under Title 32, Article 1, Colorado Revised Statutes (the "Special District Act"); and

WHEREAS, "water activity" is defined in the Act to include but not be limited to the diversion, storage, carriage, delivery, distribution, collection, treatment, use, reuse, augmentation, exchange, or discharge of water and includes the provision of wholesale or retail water or wastewater or storm water services and the acquisition of water or water rights; and

WHEREAS, "grant" in the context of the Act means a cash payment of public funds made directly to a water activity enterprise by the state or a local governmental entity or a district, which cash payment is not required to be repaid; and

WHEREAS, the District is a district under the Act which under the Special District Act and Title 31, Article 35, Part 4, Colorado Revised Statutes, has its own revenue bonding authority and which will be the sole owner of the Enterprise; and

WHEREAS, any water activity currently pursued by the District at present receives under ten percent of its annual revenues in grants from all Colorado state and local governments combined and the District intends to insure that the water activity enterprise will continue to receive under ten percent of its revenues from such grants; and

WHEREAS, the Board has determined that it is in the best interest of the District to designate its water enterprise fund and its water activities as a "water activity enterprise" pursuant to the Act and pursuant to Article X, Section 20 of the Colorado Constitution (the "Amendment"); and

WHEREAS, all capitalized words and terms used in this enterprise resolution (the "Enterprise Resolution") shall have the meanings set forth therefor in these recitals.

THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF CASCADE METROPOLITAN DISTRICT NO. 1, COUNTY OF EL PASO, COLORADO:

Section 1. Establishment of the Enterprise. The District hereby establishes and reaffirms the establishment of the Enterprise as an agency of the District and formally designates it as the "Cascade Metropolitan District No. 1 Water Activity Enterprise." It shall be the purpose of the Enterprise to pursue or continue all of the District's water activities as defined in the Act, including but not by way of limitation water acquisition or water project or facility activities, including the construction, operation, repair, and replacement of water or wastewater or stormwater facilities, using revenues and income generated by and earned or acquired in connection with such water activities and held and managed in the District's water enterprise fund. As between the District and the Enterprise, all water activities will be deemed done and furnished by the Enterprise.

Section 2. Enterprise Excluded from the Provisions of the Amendment. Pursuant to and in accordance with the Act, the Enterprise shall be excluded from the provisions of the Amendment and shall be entitled to impose rates, fees, tolls, penalties and charges; collect and spend revenues; issue revenue bonds; and construct, operate, and maintain facilities and provide water services; all without reference or regard to the limitations contained in the Amendment.

Section 3. Governing Body. The members of the Board shall serve as the governing body of the Enterprise and shall be known collectively as the Board of Directors of the Enterprise (the "Enterprise Board"). Acting as the Enterprise Board, the Board may exercise the District's legal authority relating to water activities as defined in the Act. The Enterprise Board hereby is directed to take all actions necessary to cause the Enterprise to comply with all applicable laws.

Section 4. <u>Powers of the Enterprise</u>. The Enterprise shall have all powers and authority granted to water activity enterprises by the provisions of the Act, including but not limited to the power to conduct and continue water activities as defined in the Act; the power to contract with any person or entity, including other districts as defined in the Act and other water activity enterprises as defined in the Act; and the powers to issue and reissue revenue bonds through its

governing body in accordance with and through the provisions of Section 37-45.1-104(2), Colorado Revised Statutes.

- Section 5. Enterprise Obligations and District Obligations. In consideration of the Enterprise's commitment to provide water services for which the District is obligated and to collect and spend revenues from rates, fees, tolls, penalties and charges imposed by the District, the District hereby agrees to continue to provide administrative services for the Enterprise and its activities, to continue to hold title to and own all of the assets currently owned by the District necessary to the operation of the enterprise, to levy taxes, if any, for and pay debt service on general obligation bonds of the District, if any, issued to finance the acquisition of water rights and the construction and installation of water facilities and improvements, and to impose all rates, fees, tolls, penalties and charges for water activities. The relationship between the District and the Enterprise with respect to the administration of the Enterprise, the operation of the water activities, and the duties and responsibilities of each party may be delineated and clarified from time to time in a joint resolution of the Board and the Enterprise Board which may be adopted at any time when this Enterprise Resolution is in full force and effect ("Joint Resolution").
- Section 6. <u>Transactions in the Name of the District</u>. Any and all transactions of the Enterprise may be done in the name of the District or in the name of the Enterprise and neither this Section 6 nor any transaction entered into pursuant to it shall alter or abrogate the relationship of the District and the Enterprise as established pursuant to this Enterprise Resolution and as may be further clarified from time to time in a Joint Resolution.
- Section 7. <u>Findings of the Board</u>. The Board hereby makes the following findings with respect to the establishment of the Enterprise:
- (a) The District's water enterprise fund, water rights, water activities, water facilities and appurtenances all shall comprise the Enterprise which shall be and is the water activity business owned by the District.
- (b) The Enterprise shall be and is an agency of the District for the purpose and within the meaning of the following:
- (i) Title 24, Article 10, Part 1, Colorado Revised Statutes, the "Colorado Governmental Immunity Act";
- (ii) Title 29, Article 1, Part 6, Colorado Revised Statues, the "Colorado Local Government Audit Law";
- (iii) Title 29, Article 1, Part 1, the "Local Government Budget Law of Colorado; and
 - (iv) All other local, state and federal laws, rules and regulations.
- (c) The establishment of the Enterprise is necessary to provide a secure water supply for use by the property owners within the District and other customers of the Enterprise.

- (d) The District has the authority to conduct water activities as defined in the Act and is the sole owner of the Enterprise as required by the Act. The District has revenue bonding authority for water activities pursuant to the Special District Act and Title 31, Article 35, Part 4, Colorado Revised Statutes, all as required by the Act.
- (e) The Enterprise expects to receive under ten percent (10%) of its annual revenues in grants (as defined in the Act) from all Colorado state and local governments combined, and expects to receive under ten percent (10%) of its revenues for the 2014 fiscal year from such sources.
 - (f) Pursuant to the Act, the Enterprise is authorized to issue its own revenue bonds.
- (g) The Enterprise does not and shall not levy any tax whatsoever, nor shall any rates, fees, tolls, penalties or charges collected and spent by the Enterprise ever be deemed to be taxes for any purpose under any law, rule, or regulation, whether local, state or federal.
- Section 8. <u>Termination</u>. The Enterprise shall remain in existence at the will of the Board and in accordance with law. In the event that the Enterprise is terminated by operation of law or by act of the Board, any and all assets of the Enterprise, immediately and without the need for further action, shall be deemed to be and shall be assets of the District.
- Section 9. Repealer. All orders, rules, regulations, and resolutions of the District, or parts thereof inconsistent or in conflict with this Enterprise Resolution, hereby are repealed to the extent only of such inconsistency or conflict.
- Section 10. <u>Severability</u>. If any section, paragraph, clause, or provision of the Enterprise Resolution shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause, or provision shall not affect any of the remaining provisions of this Enterprise Resolution, the intent being that the same are severable.
- Section 11. <u>Effective Date</u>. This Enterprise Resolution shall be effective immediately upon its adoption.
